



Wisconsin Well Woman Program (WWWP)

Wisconsin Well Woman Medicaid (WWWP) provides screening for breast and cervical cancer to low income, uninsured and underinsured women.

COVERS BREAST AND CERVICAL SERVICES ONLY

Office Visits

(Only when related to screening for WWWP services)

- ❖ Preventative Medicine New Client Office Visit
- ❖ Preventative Medicine Established Client Office Visit

Breast Services

- ❖ Breast Exam (manual exam performed during office visit)
- ❖ Mammogram (breast x-ray)
- ❖ Breast Ultrasound
- ❖ Other breast biopsy services **may** be covered with prior approval. Please contact your local office immediately if you need additional breast services.

Cervical Services

- ❖ PAP Test
- ❖ Pelvic Exam (only if PAP test is also performed)
- ❖ Colposcopy (with or without biopsy)
- ❖ Other cervical biopsy services **may** be covered with prior approval. Please contact your local office immediately if you need additional cervical services.

WWWP does not pay for blood tests or prescription medication of any kind.

ELIGIBILITY

- ❖ **No U.S. citizenship requirement**
- ❖ **No insurance** or major medical with high deductible.
- ❖ **Income <= 250% of Federal Poverty Guidelines**
 - household size of 1 = \$30,150
 - household size of 2 = \$40,600
 - household size of 3 = \$51,050
 - household size of 4 = \$61,500
 - household size of 5 = \$71,950
 - household size of 6 = \$82,400
 - household size of 7 = \$92,850
 - household size of 8 = \$103,300
 - add \$10,450 for each additional household member
- ❖ **Age***
 - Women, ages 45-64**, Breast and cervical screening services
 - *Exception: Women under 45 who have a current breast symptom may be eligible for breast services through WWWP and/or the Treatment Access Fund.
